ESSENTIAL CRITERIA

A) Registration

- 1) NGO should be duly registered under appropriate authority and eligible to work in the area of Corporation. NGO should have registered under NGO Darpan Portal.
- 2) NGOs applying for the project in the state other than that of its registration should have experience of working in the state for at least three years in the last seven years.
- 3) An NGO blacklisted or placed under funding restrictions by any Ministry or Department of the Government of India, State Government or Council for Advancement of People's Action and Rural Technology (CAPART) would not be eligible for applying under the Scheme.

B) Experience

- 1) Minimum 3 to 5 years experience in district level projects in health sector.
- 2) Experience of working in urban settings.
- 3) Prior work experience in similar project desired.
- 4) Experienced personnel.

C) Financial

- 1) Annual turnover of at least Rs.25 lakhs.
- 2) NGO should be financially stable.
- 3) Availability of audited certified report for last three years.
