

4. For release of first installment of Central Assistance under UIDSSMT Scheme signing of Memorandum of Agreements and ascertaining the availability of State share are the pre-requisites conditions. In this regard Memorandum of Agreements (MoAs) with the State Government of Maharashtra/ SLNA and Ministry of Urban Development, Government of India has been signed.
5. The State Government of Maharashtra has designated Directorate of Municipal Administration, Maharashtra, as the State Level Nodal Agency for implementing UIDSSMT scheme.
6. In view of the above, Department of Expenditure, Ministry of Finance is requested to release Rs. 27455.97 lakhs as first installment, to the SLNA of Maharashtra i.e. Directorate of Municipal Administration, Maharashtra under UIDSSMT during 2013-14.
7. State of Maharashtra has been released Rs. 8086.00 lakh so far during the transition period of JnNURM.
8. This issues with the approval of Hon'ble Urban Development Minister.

**OFFICE MEMORANDUM**

**Sub: - Release of Additional Central Assistance (ACA) to the State of Maharashtra for Urban Infrastructure development under UIDSSMT scheme during 2013-14.**

The undersigned is directed to say that the State Level Sanctioning Committee (SLSC) in its meeting held on 20/07/2013 at Mumbai has approved various projects under UIDSSMT Scheme. The Minutes of the SLSC meeting are placed at Annexure-I.

2. As per UIDSSMT guidelines vide Para 7:-

(I) Central Assistance (grant) released will go directly to the Nodal agencies identified by the State Government as Additional Central Assistance.

(II) Release of Central share to nodal agency will be in 50% installments and is dependent on availability of State share and submission of Utilization Certificates by nodal agency during the financial year in accordance with the provisions of General Financial Rules.

(III) 50% of the Central share will be released on signing of Memorandum of Agreement with the State nodal agency, after ascertaining availability of State share.

Balance 50% of the Central share would be released on submission of Utilization Certificates by nodal agency for 70% of funds (Central & State grants) released earlier.

(IV) State level nodal agency will, however, release funds in the following manner.

25% of Central grant on ascertaining availability of State share.

Balance Central grant after release of State grant and after assessment of progress of implementation of reforms.

3. As per decision of Cabinet Committee of Economic Affairs on 17/01/2013 the following projects may be considered for release of 1<sup>st</sup> installment of ACA.
